In case there is any objection regarding prequalifying an agency, that should be lodged to the the Authority, Asansol Municipal Corporation within 48 (forty eighty) hours (including holidays) from the date and time of publication of list of qualified agencies and beyond that time schedule no objection will be entertained by the Tender Committee.
