14	<p>In case of item rate tender, the technically qualified bidder, whose total offered price considering sum of offered prices of all the items of works taken together, stands lowest, will be considered for acceptance. In no case lowest bidder of individual items of works will be considered for acceptance for the corresponding items of works.</p>
15	<p>The Tender Inviting Authority reserves the right to cancel the NIT at any stage due to unavoidable circumstances and no claim in this respect will be entertained.</p>
16	<p>In case there is any objection regarding prequalifying an agency, that should be lodged to the the Authority, Asansol Municipal Corporation within 48 (forty eighty) hours (including holidays) from the date and time of publication of list of qualified agencies and beyond that time schedule no objection will be entertained by the Tender Committee.</p>
17	<p>Before issuance of Letter of Acceptance / Work Order, the tender inviting authority may verify the credentials & other documents of the lowest tenderer if found necessary. After verification, if it is found that such documents submitted by the lowest tenderer are either manufactured or false, in that case Letter of Acceptance / Work Order will not be issued in favour of that tenderer under any circumstances and further penal action may be taken against him as per rules.</p>
