Issuance of letter of acceptance / Work Order may be delayed and / or work may be financially restricted upto the limit of existing administrative approval until receipt of administrative approval / revised administrative approval from the competent authority (in applicable cases). Also issuance of letter of acceptance / work Order may be delayed and / or work may be restricted in some stretches till necessary land for the same is made available and / or encroachments are removed (in applicable cases). No claim, whatsoever, for such delay in issuance of Letter of Acceptance / Work Order and /or restriction of work will be entertained. Intending bidders may keep these criteria in mind while participating in tender and / or while quoting their rates
10	(a) For work with three months Defect Liability period: i) Full security deposit shall be refunded to the contractor on expiry of three months from the actual date of completion of the work. (b) For work with one year Defect Liability period i) Full security deposit shall be refunded to the contractor on expiry of one year from the actual date of completion of the work (c) For work with three years Defect Liability Period i) 30% of the security deposit shall be refunded to the contractor on expiry of two years from the actual date of completion of the work. ii) The balance 70 % of the security deposit shall be refunded to the contractor on expiry of three years from the actual date of completion of the work.
